### **10.04.010 Words and phrases defined.**

Whenever any words and phrases are used in this title, the meanings respectively ascribed to them in N.J.S.A. Title 39, subtitle 1 shall be deemed to apply to such words and phrases used herein.

**10.04.020 Official time standard.**

Whenever certain hours are named in this title, they shall mean either Eastern Standard Time or Eastern Daylight Saving Time, as may be in current use in the borough.

**10.04.030 Violation—Penalty.**

Unless another penalty is expressly provided by New Jersey Statute, every person convicted of a violation of this title or any supplement thereto shall be liable to a penalty of not more than five hundred dollars (\$500.00) or imprisonment for a term not exceeding ninety (90) days or both.

**10.08.010 Route for trucks over four tons gross weight.**

- A. The streets or parts of streets as set out in Schedule VI set out in Chapter 10.44 are designated as a route for trucks over four tons gross weight. Trucks over four tons gross weight are excluded from all other streets except for the pickup or delivery of material along such streets.
- B. Any person who shall be guilty of a violation of this chapter shall be subject to a fine of sixty-five dollars (\$65.00) for each violation.

**10.08.020 One-way streets.**

- A. The streets or parts of streets described in Schedule VII set out in Chapter 10.44 are designated as one-way streets in the direction indicated.
- B. Any person who shall be guilty of a violation of this section shall be subject to a fine of sixty-five dollars (\$65.00) for each violation.

**10.08.030 Through streets.**

Pursuant to the provisions of N.J.R.S. 39:4-140, the streets or parts of streets described in Schedule VIII set out in Chapter 10.44 are designated as through streets. Stop signs shall be installed on the near right side of each street intersecting the through street except where yield signs are provided for in the designation.

**10.08.040 Stop intersections.**

- A. In accordance with the provisions of this section, the intersection of Hull Avenue and Kiawah Avenue is designated as an all-way stop intersection. Stop signs shall be installed on all corners of the intersection of Hull Avenue and Kiawah Avenue.
- B. In accordance with the provisions of this section, the intersection of McLean Street and Randolph Street is designated as an all-way stop intersection. Stop signs shall be installed on all corners of the intersection of McLean Street and Randolph Street.
- C. In accordance with the provisions of this section, the intersection of Broad Street and Yard Avenue is designated as an all-way stop intersection. Stop signs shall be installed on all corners of the intersection of Broad Street and Yard Avenue.
- D. In accordance with the provisions of this section, the intersection of Oak Street, Brookwood Drive and Ellis Street is designated as an all-way stop intersection. Stop signs shall be installed on all corners of the intersection of Oak Street, Brookwood Drive and Ellis Street.
- E. In accordance with the provisions of this section, the intersection of Yard Avenue and Ann Street is designated as an all-way stop intersection. Stop signs shall be installed on all corners of the intersection of Yard Avenue and Ann Street.
- F. In accordance with the provisions of this section, the intersection of Institute Street and Orchard Street shall be governed by a stop sign to be placed on Orchard Street.
- G. In accordance with the provisions of this section:

The intersection of Center Street and Jackson Street be regulated by stop signs on all corners. Stop signs shall be installed on all corners of the intersection of Center Street and Jackson Street;

The intersection of East George Street and Stokes Street is hereby designated as an all-way stop intersection. Stop signs shall be installed on all corners of the intersection of East George Street and Stokes Street.

**10.08.050 Loading zones.**

The locations described in Schedule X set out in Chapter 10.44 are designated as loading zones.

**10.08.060 Speed limits.**

- A. Robertsville Road. The speed limit for traffic in both directions along Robertsville Road, for the entire length to the borough line, shall be twenty-five (25) miles per hour.
- B. Signs. Regulatory and warning signs shall be erected and maintained as required by the director of motor vehicles, and as specified in a letter of authorization, dated April 26, 1967, from the Traffic Safety Service of the Division of Motor Vehicles.
- C. The speed limit for all streets and roads, or portions thereof, located in the Borough of Freehold shall be as described in Schedule XX in Chapter 10.44 of this code.

**10.08.070 Entrances and exits.**

- A. No person in the operation of a motor vehicle shall at any time enter upon or exit from any streets or parts of streets described in Schedule XII set out in Chapter 10.44, except as provided.
- B. Any person who shall be guilty of a violation of this section shall be subject to a fine of sixty-five dollars (\$65.00) for each violation.

**10.08.080 Turn prohibitions.**

- A. Left Turn Prohibitions. No person shall make a left turn at any of the locations described in Schedule XIII set out in Chapter 10.44.
- B. U-Turn Prohibition. No person shall make a U-turn at any of the locations described in Schedule XIV set out in Chapter 10.44.
- C. No Turns. No person shall make a turn at any of the locations described in Schedule XV set out in Chapter 10.44.
- D. Lane Use Reservations. The lane locations described in Schedule XVI set out in Chapter 10.44 are designated as "lane use reservations" and traffic shall move only as indicated.
- E. Right Turn on Red Traffic Signal Prohibited. No person shall make a right turn when facing a steady red signal (STOP) indication whenever an official sign is present prohibiting such turn on the red signal as described in Schedule XVII set out in Chapter 10.44.

**10.08.090 Crosswalks.**

Pedestrian crosswalks shall be established at intersections and locations as set forth and described in Schedule XIX attached hereto and made a part of this chapter which shall be supplemented to add a pedestrian crosswalk on Barkalow Avenue at a location measuring six hundred (600) feet west of the intersection of Patten Street and a distance of four hundred (400) feet east of the intersection of Michael Lane.

**10.12.010 Regulations not exclusive.**

- A. The provisions of this title imposing a time limit on parking shall not relieve any person of the duty to observe other more restrictive provisions prohibiting or limiting the stopping, standing or parking of vehicles as set forth in N.J.R.S. 39:4-138, any other New Jersey statute or as hereinafter provided.
- B. Violation—Penalty. Any person who shall be guilty of a violation of this section shall be subject to a fine of thirty-five dollars (\$35.00) for each violation.

**10.12.020 Parking prohibited during state of emergency.**

- A. Whenever snow has fallen and the accumulation is such that it covers the street or highway, no vehicle shall be parked on any of the main traveled or major roadways or portions thereof as described in Schedule I set out in Chapter 10.44.

The above parking prohibitions shall remain in effect after the snow has ceased until the streets have been plowed sufficiently and to the extent that parking will not interfere with the normal flow of traffic.

- B. Upon the declaration of an emergency, there shall be no parking upon streets or sections of streets where temporary "EMERGENCY NO PARKING" signs are displayed. The chief of police or, in his or her absence, the ranking police officer is authorized to declare an emergency and to direct the posting of "EMERGENCY NO PARKING" signs when weather conditions, accidents, fires, public celebrations, etc., dictate or require the avoidance of hazards or other conditions which interfere with the free flow of traffic. Notification that "EMERGENCY NO PARKING" signs are being or will be posted shall be given to the operator or owner of any vehicle which has been parked prior to the posting of the signs.
- C. Any unoccupied vehicle parked or standing in violation of this chapter shall be deemed a nuisance and a menace to the safe and proper regulation of traffic and any peace officer may provide for the removal of such vehicle. The owner shall pay the reasonable costs of removal and storage which may result from such removal, before regaining possession of the vehicle.
- D. The effectiveness of this section is contingent upon signs being erected as required by law.
- E. Violation—Penalty. Any person who shall be guilty of a violation of this section shall be subject to a fine of forty-five dollars (\$45.00) for each violation.

**10.12.030 Parking prohibited at all times on certain streets.**

- A. No person shall park a vehicle at any time upon any of the streets or parts thereof described in Schedule II set out in Chapter 10.44.
- B. Violation—Penalty. Any person who shall be guilty of a violation of this section shall be subject to a fine of thirty-five dollars (\$35.00) for each violation.

**10.12.040 Parking prohibited during certain hours on certain streets.**

- A. No person shall park a vehicle between the hours specified in Schedule III set out in Chapter 10.44 of any day (except Sundays and public holidays) upon any of the streets or parts of streets described in Schedule III set out in Chapter 10.44.
- B. Violation—Penalty. Any person who shall be guilty of a violation of this section shall be subject to a fine of thirty-five dollars (\$35.00) for each violation.

**10.12.050 Parking prohibited in fire lanes.**

- A. No person shall park a vehicle at any time upon any street or public parking lot or any portion thereof designated or delineated as a fire lane.
- B. Violation—Penalty. Any person who shall be guilty of a violation of this section shall be subject to a fine of seventy-five dollars (\$75.00) for each violation.

**10.12.060 Fire lanes established.**

The entrance and exit lanes to the McGackin Triangle Parking Lot are designated fire lanes.

**10.12.070 Parking of trucks during certain hours prohibited.**

- A. No truck, bus, tractor, trailer or semi-trailer shall be parked between the hours of twelve midnight and six a.m. prevailing time on any street in the borough. This prohibition shall apply to any vehicle having six or more wheels, or any vehicle rated for loads of more than one ton.

Excluded from the above prohibition are emergency or service vehicles while actually engaged in emergency or service calls.

- B. Violation—Penalty. Any person who shall be guilty of a violation of this section shall be subject to a fine of sixty-five dollars (\$65.00) for each violation.

**10.12.080 Parking prohibited for maintenance activities.**

No person shall park a vehicle where there are displayed "TEMPORARY NO PARKING SIGNS," provided that these signs are displayed every fifty feet (50') along the street area being restricted at least thirty-six (36) hours prior to the no parking ban; and further provided, that individual notices are placed on every vehicle parked in the designated area at the time the temporary no parking signs are posted. The temporary no parking restriction may be instituted by the chief of police upon request of the department of public works or the borough administrator.

- A. When a temporary no parking restriction has been established, the police chief may, for the convenience of the residents, authorize temporary parking in areas near to the temporary no parking area for the period of time corresponding with the temporary no parking restriction. In such case, existing no parking signs shall be covered during the temporary no parking restriction period. Effected residents/businesses shall be notified of the alternate parking availability.
- B. Any unoccupied vehicle parked or standing in violation of the temporary no parking restriction shall be deemed a nuisance and a menace to the safe and proper regulation of traffic, and any

police officer may provide for the removal of the vehicle. In such event, the owner of the vehicle shall pay the reasonable costs of removal and storage which may result from such removal, before regaining possession of the vehicle.

- C. Any person parking or leaving a vehicle in a designated restricted area shall be deemed to have violated this section. Any person convicted of a violation of this section or any supplement thereto shall be liable to a penalty of not more than five hundred dollars (\$500.00).
- D. Violation—Penalty. Any person who shall be guilty of a violation of this section shall be subject to a fine of forty-five dollars (\$45.00) for each violation.

**10.12.090 No stopping or standing.**

- A. No stopping or standing of motor vehicles shall be permitted upon any of the streets or parts thereof between the hours listed in Schedule XVIII set out in Chapter 10.44.
- B. Violation—Penalty. Any person who shall be guilty of a violation of this section shall be subject to a fine of thirty-five dollars (\$35.00) for each violation.

**10.12.100 Parking at Lake Topanemus.**

- A. No person shall park a vehicle between the hours specified in Schedule XI set out in Chapter 10.44 upon any part of lands owned and operated by the borough surrounding Lake Topanemus described in the schedule.
- B. Violation—Penalty. Any person who shall be guilty of a violation of this section shall be subject to a fine of thirty-five dollars (\$35.00) for each violation.

**10.12.110 Parking in cul-de-sacs.**

- A. All motor vehicles shall be parked within designated parking spaces in all culs-de-sac located within the borough. It is unlawful for any person to park a motor vehicle in any nondesignated area located within a cul-de-sac.
- B. Violation—Penalty. Any person who shall be guilty of a violation of this section shall be subject to a fine of thirty-five dollars (\$35.00) for each violation.

**10.12.120 Overnight parking on the streets.**

**A. Commercial Vehicles.**

1. No vehicle exceeding the following standards shall be parked overnight in any residential zone:
  - a. Vehicles containing signs/markings totaling more than eighteen inches (18") by twenty-four inches (24") on any side of the vehicle;
  - b. Any vehicle which is longer than eighteen feet (18'), six inches from bumper to bumper or is more than seven feet six inches from the ground to the upper most roof, equipment rack, warning beacon or similar attachment;
  - c. Any vehicle containing equipment, contractor tools, supplies and/or materials, exposed to public view with the exception of not more than one ladder or equivalent amount of pipe mounted on a roof or bed rack.
2. Any and all vehicles exceeding the above standards must be parked in a garage or behind the rear building line.
3. No more than one vehicle with commercial license plates may be parked in any residential zone unless the vehicles are housed in a garage.
4. Excluded from the above prohibitions are vehicles of agencies providing emergency service while actually engaged in emergency or service calls.
5. This section may be read in conjunction with Section 18.72.100 and may be enforced either under the zoning ordinance or under the general police regulations.
6. This subsection shall be enforced by any appropriate official including the police department and zoning officer.

**B. Abandoned Vehicles.**

1. No vehicle shall be parked upon the street or any section of the street, roadway, alleyway or right-of-way unless that vehicle has proper license plates, valid registration, valid inspection sticker and valid insurance.
2. No vehicle shall be parked upon the public street or any section of street, roadway, alleyway or right-of-way without the vehicle being moved from that location for a period of at least one hour for more than five consecutive days.
3. Any unoccupied vehicle parked or standing in violation of this subsection shall be deemed a nuisance and a menace to the safe and proper regulation of traffic and any peace officer may provide for the removal of such vehicle upon one day's notice to the owner thereof. In the event the owner cannot be located, no such notice shall be required. The owner shall pay the reasonable costs of removal and storage which may result from such removal, before regaining possession of the vehicle.

- C. Violation—Penalty.** Any person who shall be guilty of a violation of this section shall be subject to a fine of thirty-five dollars (\$35.00) for each violation.

**10.12.130 Towing and storage fees.**

- A.** In the event a motor vehicle must be removed from private or public property, a fee may be charged according to the following schedule:

1. Towing services: \$50.00 per tow;
  2. Storage: \$15.00 per day.
- B. The police department shall be the designated agency to enforce the provisions of this section.

**10.12.140 Special parking.**

For special events such as Kruse Night, antique festivals, San Gennaro festival, Memorial Day Parade, Spooktacular and other special events occurring in the downtown and other areas of the borough, the mayor and council may establish, by resolution, for each such event, special parking and traffic regulations, may close all or a portion of certain streets to traffic, and may establish fines and penalties associated with a violation of the established regulations for each such event.

**10.12.150 Parking at the Market Yard Municipal Parking Lot.**

In the parking lot known as the Market Yard Municipal Parking Lot, there is hereby imposed, and there shall be, restricted time parking areas of twenty (20) minute[s] and three hours between the hours of eight-thirty a.m. to four-thirty p.m., Monday through Friday, excluding established holidays; and a restricted permit parking area between the hours of eight-thirty a.m. to eleven-thirty a.m. and two-thirty p.m. to four-thirty p.m. Monday through Friday, excluding established holidays; oversized vehicle parking; and Monmouth County employee/visitor parking between the hours of eight-thirty a.m. to four-thirty p.m., Monday through Friday, excluding established holidays. Those areas of time limit parking, Monmouth County employee/visitor parking and permit parking, as well as the established traffic circulation, including areas of one-way traffic circulation are as designated on the map entitled "Proposed Parking/Circulation Plan Market Yard Parking Lot", dated November 1, 2010, revised to February 7, 2011, prepared by Dynamic Engineering, which map is made a part hereof and incorporated into this section by reference, and shall be so designated by signs posted in the Market Yard Municipal Parking Lot. A copy of said map is on file in the office of the borough clerk for public inspection.

**10.12.160 Prohibition of unregistered vehicles in parking yards and parking places.**

- A. Unless authorized by a sworn law enforcement officer, no person shall operate, park, leave, allow or be in possession of a motor vehicle which is unregistered or has a suspended registration in any parking yard, lot, parking place or location, which is open to the public or to which the public is invited, whether owned or maintained by a governmental entity or in conjunction with any business or enterprise, whether public, quasi-public or private.
- B. Exemptions. This article shall not apply to:
  1. Private property to which the public is not invited, such as residential lots.
  2. Motor vehicles which are exempted from registration under N.J.S.A. Title 39, such as dealer inventory.
- C. Removal. Any police officer is authorized to order the removal of any unregistered vehicle in violation of this article to a storage space or garage, and the expense involved in such a removal and storage of the vehicle shall be borne by the owner of the vehicle, except that the expense shall be borne by the lessee of a leased vehicle.

- D. Violation—Penalty. The violation of this article shall subject the person so convicted, or pleading guilty, to a fine of one hundred fifty dollars (\$150.00).

### **10.16.010 Definitions.**

As used in this chapter, the following terms have the following meaning:

"Public building" means any building, structure, facility or complex used by the general public or to which the general public is invited, including, but not limited to theaters, concert halls, auditoriums, museums, schools, libraries, recreation facilities, public transportation terminals and stations, factories, office buildings, businesses, shopping centers, hotels or motels and public eating places whether privately or publicly owned, except that this term shall not include private family residences, warehouse storage areas and all buildings conducting hazardous occupancies that involve highly combustible, highly flammable or explosive material.

"Physical handicap" means a physical impairment which confines a person to a wheelchair, causes a person to walk with difficulty or insecurity, affects the sight or hearing to the extent that a person functioning in public areas is insecure or exposed to danger, causes faulty coordination or reduces mobility, flexibility, coordination and perception to the extent that facilities are needed to provide for the safety of that person.

### **10.16.020 Provision for parking spaces for handicapped.**

The owners of all public buildings which provide parking spaces adjacent to or used in conjunction with the public building shall within one hundred eighty (180) days of notice thereof provide for parking spaces for handicapped persons in accordance with the guidelines herein set forth and in a location and manner as determined by the code enforcement officer. Any parking facility with less than sixteen (16) existing spaces shall be exempt from the provisions of this chapter.

**10.16.030 Construction guidelines.**

Parking spaces for the physically handicapped shall be constructed according to the following guidelines:

- A. A minimum of one percent of the total number of parking spaces in the parking facility shall be used for handicapped parking, but there shall be not less than two parking spaces in each such facility.
- B. The location of the physically handicapped spaces shall be in an area of the parking facility which is most accessible and approximate to the building or buildings which the facility serves. The determination of the location shall be made by the code enforcement office in conjunction and consultation with the owner. In shopping center and other multi-store facilities, the handicapped spaces shall be as near to the flagship store as possible and/or at such other locations as may be agreeable between the code enforcement officer and the owner.
- C. Each space or group of spaces shall be identified with a clearly visible sign displaying the International Symbol of Access along with the following words: "These Spaces Reserved for Physically Handicapped Only. Special Vehicle Identification Required." The lines designating the area shall be painted in fluorescent yellow paint, and the center of the space shall be painted thereon the capital letter "H".
- D. Each space shall be twelve feet (12') wide to allow room for persons in wheelchairs or on braces or crutches to get in or out of either side of the automobile on a level paved surface suitable for wheeling and walking.
- E. Where possible, such spaces shall be located so that persons in wheelchairs or using braces or crutches are not compelled to wheel or walk behind parked cars.
- F. Where applicable, curb ramps shall be provided to permit handicapped people access from parking area to sidewalk.

Parking in handicapped space without the aforesaid vehicle identification shall create a rebuttable presumption that use of the space was not for the physically handicapped.

Any person who shall be guilty of a second or subsequent offense shall be subject to a fine of one hundred dollars (\$100.00) for each subsequent violation.

There are established the following rules and regulations governing the use of the public parking lots owned by the borough and devoted to public parking.

**10.20.020 General rules and regulations.**

- A. All motor vehicles shall be parked in the parking lots within the stalls or places designated by markers for such parking; and it is unlawful to park any motor vehicle in any parking lot, except within the limit of a designated parking stall and markers and except so as to occupy not more than one designated parking space for each motor vehicle so parked.
- B. Except for the purpose of parking in any designated parking stall, no person shall drive in the parking lots on any other line than the designated roadways, and no person shall then drive in any direction except as indicated by appropriate signs and markings in the public parking lots.
- C. No person shall operate a motor vehicle for the purpose of entering or leaving the parking lot of the borough located between East Main Street and Mechanic Street at other than the designated entrances and exits, and in accordance with the directions indicated on any signs or markings for the purpose particularly provided by Schedule XII of this title.

These areas of time limit parking are designated on a map entitled "Freehold Borough Parking Study" dated September, 1990, which map is made a part hereof and incorporated herein by reference, and shall be so designated by signs posted in the Triangle Parking Lot. A copy of the map is on file in the office of the borough clerk for public inspection during regular business hours.
- H. Violation—Penalty. Any person who shall be guilty of a violation of this section shall be subject to a fine of thirty-five dollars (\$35.00) for each violation.

**10.20.040 Broad and West Main Street parking lot regulations.**

Title 39 in order to regulate motor vehicle activities on the municipal parking lot located near the Borough Hall and Borough Fire House and upon premises designated on the Tax Map of the borough as Block 35, Lots, 18, 19, 26, 26.02, 27 and 28.

A site plan of this parking lot has been prepared by James P. Kovacs, P.E. & L.S., Abbington Associates, Inc., dated October 15, 1993, and entitled "Freehold Borough Municipal Parking, West Main

Street and Broad Street, Block 35, Lots 18, 19, 26, 26.02, 27 and 28" (hereinafter "site plan"), which site plan is on file and available for public inspection in the office of the borough clerk.

The following regulations as to the use of the parking lots near the Borough Hall and Fire House located off Broad and West Main Streets as more particularly shown on the site plan entitled "Freehold Borough Municipal Parking, West Main Street and Broad Street, Block 35, Lots 18, 19, 26, 26.02, 27 and 28" (which site plan is incorporated herein and made a part hereof as if set forth at length) are adopted.

- B. All vehicles must park only in designated areas and between the lines provided.
- C. Handicapped Parking. All stalls shall be twelve feet (12') wide as shown on the filed site plan and signed with R7-8 (reserved parking sign and penalty plate), in the designated parking areas for persons who have been issued the handicapped parking permits by the Division of Motor Vehicles.
- D. Fire Department Parking. Only a member of the Freehold fire department shall park a vehicle in any stalls designated parking areas for the Freehold fire department as shown on the filed site plan.
- E. Parking Time Limited. No person shall park a vehicle for longer than the restricted parking time limit between the hours of seven a.m. to seven p.m. on any day (except Sunday):  
  - As shown on the filed site plan.
- F. Stopping or Standing Prohibited on Certain Streets. No person shall stop or stand a vehicle upon any of the streets or parts of streets set forth on the filed site plan.
- G. Speed Limits.
  - 1. The speed limits for both directions of traffic in the parking lot shall be fifteen (15) miles per hour.
  - 2. Regulatory and warning signs shall be erected and maintained to effect the above designated speed limits.
- H. Through Street. The following streets or parts of streets are designated as through streets. Stop signs shall be installed on the near right side of each street intersecting the through street, except as shown on the attached site plan.  
  - As shown on the filed site plan.
- I. Stop Intersection. The following intersections are designated as stop intersections. Stop signs shall be installed as provided therein:

- J. One-Way Streets. The following described streets or parts of streets are designated as one-way streets in the direction indicated:  
  - As shown on the filed site plan.

  - As shown on the filed site plan.
- M. Left-Turn Prohibitions. No person shall make a left turn at any of the following locations:

- P. Tractor Trailers Excluded. Tractor trailers are excluded from the entire parking lot complex.
- Q. Tow-Away. Any vehicle parked or standing as to obstruct or impede a normal flow of traffic, block entrances or exit ways, block or park upon any grass or landscaped area or pedestrian walkway, or that otherwise presents a safety or traffic hazard may be removed by towing the vehicle at the owner's or operator's expense.
- R. All signs, posts, or other necessary materials to be installed shall meet state and federal specifications, and all signing shall conform to the current Manual on Uniform Traffic Control Devices.
- S. Violation—Penalty. Unless another penalty is expressly provided by New Jersey Statute, any person who shall be guilty of a violation of this section shall be subject to a fine of thirty-five dollars (\$35.00) for each violation.

**10.20.050 Court and Broad Street parking lot regulations.**

- A. Preamble. The governing body deem it desirable to adopt traffic and parking regulations pursuant to N.J.S.A. Title 39 in order to regulate motor vehicle activities on the municipal parking lot commonly known as the Court and Broad Street Parking Lot, which premises are designated on the Tax Map of Freehold Borough as Block 36, Lots 1, 2, 10, 10.1, 11, 12 and 13.

All prior regulations shall be rescinded and superseded by the following regulations.

A site plan of this parking lot has been prepared by Abbington Engineering, LLC, dated September 29, 2014, and entitled "Court Street Parking Lot" (hereinafter "site plan"), which site plan is on file and available for public inspection in the office of the borough clerk. The filed site plan is incorporated herein and made a part hereof as if set forth at length herein.

- B. In the parking lot known as the Court and Broad Street Parking Lot, there is hereby imposed, and there shall be restricted time parking areas of three hours between the hours of eight-thirty a.m. to four-thirty p.m., Monday through Friday, excluding established holidays; and a restricted permit parking area between the hours of eight-thirty a.m. to eleven-thirty a.m. and two-thirty p.m. to four-thirty p.m. Monday through Friday, excluding established holidays. Those areas of time limit parking and permit parking, as well as the established traffic circulation, including areas of one-way traffic circulation are as designated on the map prepared by Abbington Engineering, LLC, dated September 29, 2014, and entitled "Court Street Parking Lot," which map is made a part hereof and incorporated into this section by reference, and shall be so designated by signs posted in the Court and Broad Street Parking Lot. A copy of said map is on file in the office of the borough clerk for public inspection.
- C. All vehicles must park only in designated areas and between the lines provided.
- D. Parking Time Limited. No person shall park a vehicle for longer than the restricted parking time limit as shown on the filed plan.
- E. The speed limits for both directions of traffic in the parking lot shall be fifteen (15) miles per hour.
- F. Stop Intersections. The following intersections are designated as stop intersections:  
Northeasterly driveway at the exit to Broad Street;



Middle driveway at the exit to Court Street.

And as depicted on the filed map.

- G. One-Way Streets. The following described streets or parts of streets are designated as one-way streets in the direction indicated:

Southwesterly driveway from Broad Street;

Northeasterly driveway to Broad Street;

Southeasterly driveway from Court Street.

And as depicted on the filed map.

- H. Violation—Penalty. Unless another penalty is expressly provided by New Jersey Statute, any person or entity found guilty of a violation of this section shall be subject to a fine of thirty-five dollars (\$35.00) for each violation.

**10.24.010 Business district.**

There are established the following business permit parking areas within the public parking areas owned and operated by the borough:

- A. Designated areas of the Broad and West Main Street Parking Lot;
- B. Designated areas of the Market Yard Parking Lot;
- C. Designated areas of the Court/Broad Street Parking Lot.

**10.24.020 Issuance of permits.**

- A. The borough clerk shall issue to eligible applicants, a numbered and color coded parking permit which shall entitle the holder thereof to park a passenger motor vehicle in the permit parking area specified on the permit in any space designated and reserved for permit parking, subject to the rules and regulations set forth in this chapter.
- B. To be eligible to receive a parking permit for the permit parking areas in the Market Yard Parking Lot and the Court/Broad Street Parking Lot, an applicant must meet one of the following criteria:
  - 1. Reside in an apartment in the central business district which does not have parking available at the site of the building, or which has inadequate parking available on site or adjacent to the site of the building;
  - 2. Own and operate a business in the business district which does not have parking available at the business site or which has inadequate parking available at the business site;
  - 3. Operate a business or be employed in a business which does not have adequate parking available at the business site or which has inadequate parking available at the business site;
  - 4. Be assigned to or required to be at a location in the business district for business purposes for an extended period of time, provided that this business location does not have alternate parking available to its visitors and/or employees;
  - 5. A business owner/operator may obtain one-day permits for visitors to his or her establishment requiring all day parking for a specific event, if the parking at the business establishment is inadequate;
  - 6. A group staging a special event/trip may obtain a special one-day parking permit for that specific event, provided it is shown that it is not feasible for the group to depart from or meet at another location. The group and/or event must benefit Freehold Borough residents or businesses.
- C. The parking regulations as set forth in the zoning and site plan ordinances of the borough shall be the determinant of the number of parking spaces required for any applicant seeking parking permits. For the purpose of subsection (B)(1) through (3) of this section, inadequate parking shall be defined as fewer on-site parking spaces than stipulated in the zoning and site plan ordinances of the borough. The borough clerk may issue parking permits for a specific site that equal the total parking

requirements of the zoning and site plan ordinances for that business/resident location, less the available parking provided on site or at other facilities controlled by the applicant.

All permits shall be in the form prescribed by the borough mayor and council by resolution. Every permit shall be prominently displayed and plainly visible through the windshield of the vehicle.

Use of a municipal parking lot shall be at the owner's risk.

  - July, August, September
  - October, November, December

**10.28.030 Exceptions.**

The following vehicles shall be exempt from this parking permit section:

- A. Visitors. A vehicle displaying a current visitor parking permit may park a maximum of seven days, provided that the operator of the vehicle is a bona fide guest of a resident within the permit parking area. The visitor's permit shall be displayed on the dashboard of the vehicle in such a manner as to be clearly visible by an officer enforcing parking restrictions.

Two visitor's permits shall be issued to each residential unit on any street or portion thereof upon which parking is restricted by this section. It shall be a violation of this section for persons other than bona fide visitors to utilize visitor's parking permits.

Additional visitor's parking permits, as described herein, shall be issued for special events by the borough clerk or the borough police department upon the filing of a written application by the homeowner seeking the visitor's parking permit. Such permit shall be valid only for the duration of the special event.

- B. Contractor, Service and Delivery Vehicles. Contractors, service and delivery vehicles bearing the name and address of a commercial business may park without permit during the time they are rendering service to a residence within the permit parking area.
- C. Emergency Vehicles. Emergency vehicles and public service, telephone and other public utility vehicles may park within the permit parking area during the time they are rendering service or repairs within the area.

### **10.29.010 Creation.**

The streets and portions of streets identified in Schedule A listed and incorporated in Section 10.29.030 are designated as permit parking areas.

**10.29.020 Parking by permit only in designated residential areas.**

No vehicle shall be parked on the streets or parts of streets designated in Schedule A in Section 10.29.030 and made a part hereof (a copy of which is on file in the office of the borough of clerk) during the hours of seven a.m. to nine a.m., Monday through Friday unless:

- A. The vehicle is owned or operated on a regular basis by a resident of that street; and
- B. The vehicle has displayed in such a manner as to be visible and able to be closely examined by an officer enforcing parking restrictions, a current residential parking permit; or
- C. The vehicle falls under one of the exemptions to the parking ban.
- D. Violation—Penalty. Any person who shall be guilty of a violation of this section shall be subject to a fine of thirty-five dollars (\$35.00) for each violation.

**10.29.030 Designated streets.**

**10.29.040 Exceptions.**

The following vehicles shall be exempt from this parking permit section:

- A. Visitors. A vehicle displaying a current visitor parking permit may park a maximum of seven days provided that the operator of the vehicle is a bona fide guest of a resident within the permit parking area. The visitor's permit shall be displayed on the dashboard of the vehicle in such a manner as to be clearly visible by an officer enforcing parking restrictions.

Two visitor's permits shall be issued to each vehicle that has been issued a residential permit for this area. It shall be a violation of this section for persons other than bona fide visitors to utilize visitor's parking permits.

Additional visitor's parking permits, as described herein, shall be issued for special events by the borough clerk or the borough police department upon the filing of a written application by the homeowner seeking the event.

- B. Contractor, Service and Delivery Vehicles. Contractors, service and delivery vehicles bearing the name and address of a commercial business may park without permit during the time they are rendering service to a residence within the permit parking area.
- C. Emergency Vehicles. Emergency vehicles and public service, telephone and other public utility vehicles may park within the permit parking area during the time they are rendering service or repairs within the area.

### **10.32.010 Definitions.**

As used in this chapter, the following words and terms shall have the following meanings, unless the context clearly indicates otherwise:

"Automobile" shall mean a private passenger automobile, sports utility or station wagon type that is owned, leased or rented and is neither used as a public or livery conveyance for passengers, nor rented to others with a driver; and a motor vehicle with a pickup body or delivery sedan, a van, or a panel truck or a camper-type vehicle used for recreational purposes owned by an individual or by individuals who are

residents of the same household, not customarily used in the occupation, profession or business of the insured other than farming.

"Basic towing service" shall mean a removal and transportation of an automobile from a highway, street or other public or private road, or a parking area, or from a storage facility, and other services normally incident thereto, but does not include recovery of an automobile from a position beyond the right-of-way or berm, or from being impaled upon any other object within the right-of-way or berm.

"Borough storage facility" shall mean a storage area or lot owned and/or operated by the Borough of Freehold.

"Commercial vehicle" shall mean any vehicle other than that as defined as an automobile pursuant to definitions as contained in this chapter.

"Disabled vehicle" shall mean any motor vehicle which is unable to operate safely and properly under its own power.

"Impounded vehicle" shall mean a vehicle which, at the direction of the police department, is taken into police custody because the operator of the vehicle was alleged by a police officer to be engaged in a violation of the law, including but not limited to, the operator being arrested on a DUI charge, the operator having been arrested for driving without registration or insurance, or the operator having been arrested for stealing the motor vehicle, or the vehicle having been involved in a serious motor vehicle accident.

"Storage rate charges" shall mean the maximum available amount to be charged by a storage facility for a twenty-four-hour period or fraction thereof. A new twenty-four-hour period begins at 12:01 a.m. and ends at 11:59 p.m.

"Tow list" shall mean a list of towing and storage contractors maintained by the police department containing the names and addresses of towing and storage contractors who will be called on a rotating basis when the police department determines that the assistance of such services are required within the borough.

"Tow vehicle" shall mean only those vehicles equipped with a boom or booms, winches, slings, tilt beds, wheel lifts or under-reach equipment specifically designed by the manufacturer for the removal or transport of motor vehicles.

"Tow vehicle's base of service" shall mean the towing operator's principal place of business where the tow vehicle is stationed when not in use.

"Towing and storage contractor" shall mean an entity engaged in providing vehicle towing and storage services for vehicles which have been towed.

### **10.32.020 Establishment and operation of tow list, enforcement.**

- A. There is hereby established a rotating list of towing and storage contractors authorized to provide vehicle towing and storage services as required by the Borough of Freehold. The chief of police or designee shall be responsible for the administration of the rotating list. Any towing and storage contractors qualifying pursuant to this section shall be included on the list and those on the list shall be called on a rotating basis to provide the required towing and storage services. Whenever a towing and storage contractor is called through the police department, whether as a result of being next on the tow list, or for another reason, that towing and storage contractor will rotate to the bottom of the list. Nothing contained herein shall prevent the chief of police or designee from requesting additional towing service from others in the event none of the contractors on the rotating list are available or are unable to provide such services as requested by the borough, or, if, in the judgment of the chief or designee, the size, nature or scope of the accident conditions or the performance of the called towing service requires that assistance be rendered. Nothing herein shall be construed so as to prevent any owner or operator of a motor vehicle from selecting his or her own towing service.

- B. The chief of police or member of the police department designated by the chief is authorized to enforce the provisions set forth in this chapter.

**10.32.030 Annual application and fee.**

Application for inclusion on the official tow list shall be made annually between January 1 and January 30, together with an application fee of two hundred fifty dollars (\$250.00). By filing such application, the applicant shall agree to the conditions outlined on the application, including compliance with all provisions of this section.

Unless the original annual rotating list has been depleted or reduced to a number which the chief or designee deems unsatisfactory, no contractors shall be added to the list during the calendar year.

A. All applications shall include the following information:

1. The name, residence, business address and telephone number of the owner of the towing company. If the owner is a corporation or an LLC, the application shall contain the name, residence and business address and telephone number of every stockholder or member owning more than ten (10) percent of the issued stock or membership shares.
2. Such information as may be required by the borough council concerning the personnel, vehicles, equipment, and storage facilities of such applicant as herein provided, showing that the applicant meets the minimum standards of performance.
3. A certificate or certificates of insurance evidencing adequate insurance coverage as herein provided.
4. An annual fee of two hundred fifty dollars (\$250.00), plus an additional fee of twenty dollars (\$20.00) for each background/criminal history check conducted by the borough on each employee. Background checks will be completed one time for each employee. These background checks are necessary and will be done in the interests of public safety.
5. Each towing applicant and its personnel must execute and sign a New Jersey State Police request for criminal history check for a noncriminal justice purpose.
6. Each towing applicant and its personnel must obtain and furnish to the borough a copy of their own individual New Jersey Department of Motor Vehicles driver abstract.
7. The names and addresses of at least two business references that have known the applicant for at least two years and can attest to the applicant's experience and performance in the towing, wrecking, and storage business.

**10.32.040 Performance and vehicle requirements.**

- A. Services and Standards of Performance. Towing contractor[s] shall furnish adequate and proper wrecking, towing, storage and emergency repair services to motor vehicles damaged or disabled within the limits of the borough, when requested to do so by the chief of police or the authorized designee.

No official towing contractor shall subcontract any work to be performed pursuant to this chapter except in an emergency situation.

- B. Minimum Vehicle/Equipment/Safety Requirements. To qualify for inclusion on the list of official towing contractors, applicants must meet the following minimum standards:

1. The towing service must have ownership of two professionally constructed tow vehicles, one of which being a "flatbed" type of vehicle capable of removing certain types of damaged vehicles or those, which by design, cannot be removed by conventional wreckers without sustaining additional damage.
2. All towing vehicles used in the performance of the contract must meet the standards specified by the State of New Jersey Motor Vehicle Codes and this specification in all respects. Each applicant is required to list all equipment/vehicles to be used including registered name, type and license number of each.

The borough reserves the right to make periodic, unannounced inspections of vehicles, equipment, storage areas and personnel.

3. At least one of the available tow vehicles must be equipped for dolly service and winching.
4. The towing service must have and maintain communication equipment between vehicles and its dispatchers via two-way radio.
5. Every tow vehicle or flatbed vehicle shall be equipped with at least one amber rotating beacon or strobe light mounted on the highest practical location of the vehicles, safety tow lights or magnetic tow lights for towing vehicles at night, amber colored.
6. All tow vehicles must carry road cleanup equipment and supplies such as brooms, rakes, trash cans and shovels; each tow vehicle shall carry portable fire extinguishers, one dozen flares or similar warning devices for placement at the scene of an accident or behind a disabled vehicle, ten (10) pounds of dry sand or a drying compound for gasoline and oil spilled onto the roadway and a sufficient quantity and types of tools to enable the tow operator to perform property [properly] and adequate emergency repair services for the tow.
7. All towing and tow type vehicles and all other vehicles shall be properly licensed and registered with the New Jersey Division of Motor Vehicles.
8. The towing service is responsible for the prompt and safe removal of the disabled vehicle and for the prompt and complete removal of all litter and debris resulting from the accident.
9. Tow vehicles shall have the name, address and telephone number of the contractor painted or permanently attached to both sides of the vehicle in compliance with state law.

### **10.32.050 Insurance.**

- A. The towing and storage contractor shall maintain the minimum insurance coverage in the name of the applicant:
  1. Automobile liability in an amount not less than one million dollars (\$1,000,000.00) combined single limits.
  2. Workers compensation as required by statute.
  3. Garage keepers liability in an amount not less than sixty thousand dollars (\$60,000.00) per location.
  4. Garage liability in an amount not less than one million dollars (\$1,000,000.00) combined single limit.
  5. Policies enforced to provide collision coverage for vehicles in tow.
- B. At the time of the application, the towing and storage contractor shall present a certificate of insurance evidencing the above coverage by an insurance company licensed to do business in the State of New Jersey. Included on such certificate shall be a statement that the insurance company or agent will notify the chief of police immediately of any change, cancellation or lapse of such coverage. Such

statement shall not include language making such notification permissive nor language absolving the company/agent from liability for failure to notify.

**10.32.060 Indemnification/hold harmless.**

By virtue of making application to be included on the tow list, the applicant is deemed to agree to indemnify and hold harmless the Borough of Freehold, its elected officials, boards, commissions, officers, employees and/or agents from all suits, actions, damages or claims, fees, costs, expenses, fines or penalties to which the borough may be subjected of any kind and nature whatsoever resulting from, caused by, arising out of or as a consequence of the provisions of towing, wrecking, storage and/or emergency services provided at the request of the borough pursuant to this chapter.

**10.32.070 Minimum personnel standards and requirements/availability and response time.**

- A. The following are the minimum standards/qualifications required to be considered for inclusion on the tow list:
1. The official towing and storage contractor shall have available at all times a minimum of two persons to provide the services required by this chapter. All persons employed by the towing contractor to provide the services required by this chapter shall meet the following requirements and be subject to the following regulations. They shall:
    - a. Be competent to provide minimum road service for disabled vehicles;
    - b. Have a valid driver's license having no restrictions or conditional endorsements other than a condition requiring the wearing of eyeglasses;
    - c. Be mentally alert and present a neat appearance at all times;
    - d. Obey all traffic laws and regulations;
    - e. Be subject to inspection by the chief of police and be approved by the chief of police prior to rendering services;
    - f. Not have been convicted of a crime nor had their driving privileges suspended or revoked within the past year.
  2. Towing and storage contractors must be prepared to properly clear the roadway of any or all types of disabled vehicles. Where the vehicles are too large for the service to remove from the scene, after clearing the roadway, the service may call for assistance of others. The towing and storage contractor is required to have appropriate arrangements for this assistance at all times.
  3. Employees of the towing operator, in responding to a call, shall request and be afforded police assistance during the course of providing towing, emergency road services or removal of abandoned or accident vehicles when such employees find it necessary to turn around, back up, tow in the opposite direction of traffic, or cross the median.
  4. The towing service must operate a suitable, fenced and secure vehicle storage area in an area zoned for such use. The lot must be able to store at least twenty-five (25) full-size vehicles. Said storage yard must be within a two-mile radius of the Borough of Freehold. If there are in excess of twenty-five (25) vehicles to be stored, they may be stored elsewhere as long as the alternate lot complies with the specifications of the regular storage lot, and appears on the towing and storage contractor's insurance certificate. Upon request, authorized personnel of the police

department shall be able to have access to vehicles twenty-four (24) hours per day within the storage area.

5. A towing operator shall not permit a vehicle to be removed from the site of a vehicular accident, the scene of a crime or any other instance or situation without the prior approval and permission of a police officer and/or superior at the scene.
6. The towing and storage contractor must meet the following response times within the Borough of Freehold:
  - a. At all times the towing operator must answer the telephone call by police or police designee. If the towing and storage contractor fails to answer the police telephone call for service, the police or designee shall move to the next contractor on the list.

Response time to the scene determination is to be initiated when the police call requesting towing is completed. Where the police cannot reach the next eligible contractor on the tow list by telephone, that contractor shall be deemed to have forfeited its position and the next succeeding contractor on the list shall be called.

- b. Day (seven a.m. to seven p.m. seven days per week) fifteen (15) minutes to respond to scene.
  - c. Night (seven p.m. to seven a.m. seven days per week) twenty (20) minutes to respond to scene.
  - d. Large vehicle service requirements; normal day or night response time plus thirty (30) minutes when required.
- B. Performance Standards. The towing and storage contractor will meet the following response performance standards:
1. Ninety (90) percent of all calls referred will be answered (both telephone call and towing vehicle on scene) within the response time outlined above.
  2. Not more than ten (10) percent of the calls will be answered within an additional ten (10) minutes (day or night).
  3. No response will be later than twenty-five (25) minutes (whether day or night), with the exception of response time set forth above regarding large vehicle service requirements.
- C. Failure to Respond.
1. The performance standard will be reviewed periodically. Where the towing and storage contractor performance record is found to be unsatisfactory, it will be removed from the tow list for at least six months and until it shall have provided satisfactory evidence to the chief of police that it has undertaken effective steps and implemented such procedures as are necessary to meet the foregoing performance standards.
  2. In the event a towing and storage contractor fails to meet the performance standards on two occasions in the same calendar year, the chief of police or designee may issue a summons for such failure. The fine for such violation shall be a minimum of one hundred dollars (\$100.00) [and] a maximum of one thousand dollars (\$1,000.00).

### **10.32.080 Minimum storage requirements.**

Every official towing and storage contractor shall maintain an outside secured storage area meeting the following requirements:

- A. The storage area shall be capable of storing a minimum of fifteen (15) full-sized passenger vehicles and one tractor trailer in an area zoned for such use. The area shall have at least eight hundred (800) square feet of storage facilities to hold and protect "police hold" vehicles.
- B. The location of the storage area shall be either within the limits of the Borough of Freehold or at such location outside of the Borough of Freehold as to facilitate reasonable towing distances and in no event more than a two-mile radius of the Borough of Freehold.
- C. The storage area shall be in an area legally zoned for such use.
- D. The storage facility shall be available to the police twenty-four (24) hours per day, three hundred sixty-five (365) days per year and shall be open to the public on weekdays during normal business hours and for four hours on Saturdays. The applicant shall specify the hours on which the facility will be open on Saturdays.
- E. The towing and storage contractor shall have an employee on duty during all hours in which the storage facility is open to the public.
- F. The towing and storage contractor shall not charge a release fee or other charge for releasing vehicles to their owners after normal business hours or on weekends.
- G. The applicant shall, with its application, submit proof of ownership or lease of a storage area meeting the above requirements for its exclusive use. In the event a storage lot is shared by other towing and storage contractors, each contractor must show that there is an area meeting the within requirements available for each contractor utilizing the yard, with no overlap of use.
- H. The official towing and storage contractor shall be responsible for ensuring the proper and safe storage of all vehicles towed pursuant to this chapter. The official towing and storage contractor shall be liable for any damage occurring to such vehicles while in transit to or while stored in the storage areas.
- I. All impounded vehicles shall be removed to the borough storage facility unless otherwise directed by borough police. The towing contractor shall submit its bill for tow services to the customer. To secure release of the vehicle, after the police impound has been lifted, the vehicle must present proof of payment of the tow services and must pay to the borough the daily storage fee provided herein as well as any vehicle release fee charged by the borough.

### **10.32.090 Inquiries.**

Inquiries regarding a towing and storage contractor's position on the tow list, violations by other towing and storage contractors or any other matter related to performance under this chapter must be made in writing and addressed to the chief of police.

### **10.32.100 Towing and storage fee schedule.**

- A. Fees for towing and storage may not exceed the fees established by the New Jersey Department of Insurance pursuant to N.J.S.A. 17:33B-47.
- B. No towing and storage contractor shall charge fees in excess of those set forth in this section. Allowable fees are as follows:
  - 1. General towing fees:
    - a. Vehicles up to thirty thousand (30,000) pounds.

- (1) Light-duty tow rates: Sixty-four dollars (\$64.00) for hook up and first mile with a maximum charge of eighty-one dollars (\$81.00) may be charged between the hours of five p.m. and seven a.m. Motorcycles, station wagons, minivans and pickup trucks with a gross vehicle weight under eight thousand (8,000) pounds shall be considered the same as passenger automobiles for the purpose of determining rates. There will be a charge of three dollars and seventy-five cents (\$3.75) per mile for each additional mile of towing to the authorized facility.
  - (2) Gross weight between eight thousand one (8,001) and ten thousand (10,000) pounds: One hundred six dollars (\$106.00) for hook up and first mile. There will be a charge of five dollars (\$5.00) per mile for each additional mile of towing to the authorized facility.
  - (3) Gross weight between ten thousand one (10,001) and fifteen thousand (15,000) pounds: One hundred twenty-five dollars (\$125.00) for hook up and first mile. There will be a charge of five dollars (\$5.00) per mile for each additional mile of towing to the authorized facility.
  - (4) Gross weight between ten thousand one (10,001) and fifteen thousand (15,000) pounds: One hundred twenty-five dollars (\$125.00) for hook up and first mile. There will be a charge of five dollars (\$5.00) per mile for each additional mile of towing to the authorized facility.
  - (5) A maximum fee of thirty-one dollars (\$31.00) per service shall be permitted for the pulling of axles or disconnecting driveshafts.
- b. Heavy-duty tow rates (vehicles between thirty thousand one (30,001) and eighty thousand (80,000) pounds).
- (1) The maximum fee of two hundred eighty-one dollars (\$281.00) for hook up and first mile of towing. There will be a charge of six dollars and twenty-five cents (\$6.25) per mile for each additional mile of towing to the authorized facility.
  - (2) A maximum fee of thirty-one dollars (\$31.00) per service shall be permitted for the pulling of axles or disconnecting driveshafts.
  - (3) For every day of dead outdoor storage, twenty-five dollars (\$25.00) per day for passenger automobiles, trucks and omnibuses, under eight thousand (8,000) pounds gross vehicle weight, forty-four dollars (\$44.00) per day for medium-duty vehicles and sixty-three dollars (\$63.00) per day for heavy-duty vehicles.
  - (4) Waiting time and/or winching time for wreckers may be charged forty-four dollars (\$44.00) per one-half hour. Waiting time shall not begin until at least one-half hour after the time of arrival of the tow truck/wrecker at the scene.
- c. Towing services to private passenger vehicles when requested privately by individuals shall be at the rates as agreed to between the individual and the towing contractor.
- d. Tow vehicles transporting multiple passenger cars at one time shall receive the applicable fees for each vehicle transported.

### **10.32.110 Miscellaneous provisions.**

- A. Authorized Service Receipt Form. Towing and storage contractor will complete and file with the police department a towing service receipt form for every vehicle serviced on borough assignment. The towing and storage contractor will provide the following:
1. A pre-printed form supplied by the towing and storage contractor including at least the following information:

- a. Towing and service fees schedule;
  - b. Authorized service business name, address and business telephone number;
  - c. Time, location and vehicle information;
  - d. Towing representative's signature; and
  - e. Service charge and fees.
2. The receipt will be multi-copy and issued as follows:
- a. Original. Issued immediately to owner upon completion of service and payment of bill.
  - b. Police. Issued monthly to police department upon completion of services.
  - c. Owner's Accident Receipt. Issued at the accident site to the owner prior to removal of the vehicle. In the event the owner is incapacitated or disputes the assignment, the owner's accident receipt may be issued to the police department.
  - d. Copies. As deemed necessary by towing service.
- B. Follow-up Report. A monthly report must be filed with the police department containing the following information:
1. Description of each vehicle towed pursuant to request by police department during month for which report is given.
  2. Name and address of title owner of vehicle.
  3. Date vehicle was towed.
  4. Amount charge for tow.
  5. Amount charged for storage to date of report.
  6. Date vehicle was released.
  7. List of all vehicles towed pursuant to police department request which are unclaimed for over thirty (30) days.
- C. Storage Provision During Emergency Condition. During emergency conditions (snowstorm, etc.) the towing and storage contractor must provide additional vehicle storage spaces as needed. Said storage space does not have to be located at the primary facility. Said spaces will only be used during the period of the aforesaid emergency.

### **10.32.120 Enforcement/penalties.**

- A. In the event that a person or entity shall fail to perform satisfactorily, or performs in violation of this chapter, such person or entity may immediately be removed from the tow list by the chief of police. As soon as practical after such removal, the chief of police shall cause written notice of such removal to be given to the person or entity removed. The notice shall set forth the reason for such removal. The person or entity removed shall have the right to submit, in writing, such rebuttal as deemed appropriate and an explanation of the steps being taken and procedures being implemented to correct any deficiencies. After review of such response, the chief of police or designee may continue their removal from the list, return the person or entity to the list either immediately or after a specified period of time.
- B. Availability of Towing and Storage Fees. The police department and the office of the borough clerk shall maintain copies of this chapter as well as copies of all fee schedules of towing and storage contractors submitted to the borough pursuant to this chapter, which fee schedule shall be available for inspection by the public during regular business hours of the municipalities.

- C. Any person or entity found to have violated any section of this chapter or ordinance, or to have submitted a false or misleading application shall, in addition to removal from the tow list, be subject to the following fines under penalties:
1. Upon conviction, be punished by a fine not to exceed one thousand dollars (\$1,000.00); each violation of any of the provisions of this chapter and each day the same is violated shall be deemed and taken to be a separate and distinct offense.
  2. In addition to the fine provided above, a violation of the provisions of this chapter shall be cause for suspension and removal from the official tow list.
  3. The police department or any member thereof is hereby declared to be the enforcement agency of this chapter in accordance with due process of law.

### **10.36.010 Designation of school crossings.**

In accordance with and pursuant to the authority of P.L. 1999, Ch. 185, the following is a list of school crossings which have been so designated by the Borough of Freehold: (on file in the office of the borough clerk).

**10.36.020 Adoption of map.**

The drunk driving free school zones map produced by the borough engineer is approved and adopted as an official finding and record of the location of areas within the municipality of property which is used for school purposes and which is owned or leased to any elementary or secondary school on school land and of the areas on or within one thousand feet (1,000') of such school property.

**10.36.030 Map and list to constitute official findings.**

The drunk driving free school zones map approved and adopted pursuant to Section 10.36.020 shall continue to constitute an official finding and record as to the location and boundaries of areas on or within one thousand feet (1,000') of property owned by or leased to any elementary or secondary school or school board which is used for school purposes until such time, if any, that this chapter shall be amended to reflect any additions or deletions with respect to the location and boundaries of school property and drunk driving free school zones. The list of school crossings designated above by the borough council shall continue to constitute an official finding and record of the location of school crossing zones within the borough until such time, if any, that this chapter shall be amended to reflect any additions or deletions with respect to school crossing zones in the borough.

**10.36.040 Changes in locations or boundaries.**

The school board, or chief administrative officer in the case of any private or parochial school, is directed and shall have the continuing obligation to promptly notify the office of the borough engineer and the borough attorney of any changed or contemplated changes in the location and boundaries of any property owned or leased to any elementary or secondary school or school board, which is used for school purposes or of any additions or deletions to school crossings.

**10.36.050 Original map and list to be on file.**

The borough clerk is directed to receive and keep on file the original of the map approved and adopted pursuant to Section 10.36.020 and the list of school crossings and to provide, as a reasonable cost, a true copy thereof to any person, agency or court which may from time to time request such a copy, along with a certification that such copy is a true copy of the map approved and adopted herein and kept on file. It is further directed that a true copy of such map and list and of this chapter shall be provided without cost to the Monmouth County clerk and to the office of the Monmouth County prosecutor.

**10.36.060 Map and list evidence.**

The following additional matters are determined, recited and stated:

It is understood that the map and list approved and adopted pursuant to this chapter was prepared and is intended to be used as evidence in prosecutions arising under the criminal and traffic laws of this state and that, pursuant to state law, such map and list shall constitute prima facie evidence of the following:

- A. The location of elementary and secondary schools within the municipality;
- B. The boundaries of the real property which is owned by or leased to such schools or a school board;
- C. That such school property is and continues to be used for school purposes;
- D. The location and boundaries of areas which are on or within one thousand feet (1,000') of such school property;
- E. The location of all school crossings in the borough.

### **10.40.010 Definitions.**

As used in this chapter:

"Bicycle" means a device having a wheel or wheels with tires, twelve inches (12") or more in diameter, connected by a frame of metal or wood and so arranged as to be propelled by human power. This definition does not apply to toy bicycles, children's tricycles, velocipedes or baby carriages.

"Roadway" means that portion of a highway improved, designated or ordinarily used for vehicular travel exclusive of the berm or shoulder.

"Sidewalk" means that portion of a highway intended for the use of pedestrians, between the curb line or the lateral line of a shoulder, or, if none, the lateral line of the roadway and the adjacent right-of-way line.

**10.40.020 Registration and license required.**

No person shall operate or use a bicycle upon any street, road, avenue, public highway, lane or sidewalk in the borough unless it has been registered, as hereinafter provided, and a registration sticker, duly numbered and recorded at police headquarters, has been affixed to the bicycle or similar vehicle, as hereinafter provided. Further, no person, shall rent or hire out for use a bicycle or similar vehicle, unless it shall first be registered and a registration sticker, duly numbered, has been affixed to the bicycle or similar vehicle, as hereinafter provided. This section shall apply to a person who resides within the borough for twenty-one (21) days or over and who operates a bicycle within the limits of the borough more than casually or on a transit basis.

(Prior code § 5-10.2)

**10.40.030 License regulations.**

- A. Application. Application for a bicycle license and license decal shall be made upon a form provided by the borough and shall be made to the chief of police. The license decal shall be issued by the police department upon receiving proper application from an adult, or parent or guardian, and shall be effective until May 1st of each year thereafter, annually licenses shall be issued during the month of April for each succeeding year, to be effective from May 1st until April 30th. Any license obtained during the license year shall be effective only until the end of that license year, and a new license must be obtained at the time. A newly purchased bicycle shall be licensed within fourteen (14) days of acquisition.
- B. Fee. The license fee to be paid for each bicycle shall be fifty cents (\$.50) per year, or any part thereof; fees to be remitted by the police department to the borough treasury.
- C. Inspection. No person shall be issued a license certificate, until it is determined through examination by the police department that the bicycle is in safe mechanical condition to operate; that the applicant has the ability to operate the bicycle and that he or she has the knowledge of the rules and regulations promulgated by the police department as to the operation of bicycles in the borough.
- D. Records of Licenses. The chief of police shall keep a record of the number of each license, the date issued and the name and address of the person to whom issued.
- E. License Display. The license sticker shall be attached to the rear portion of the frame of the bicycle and kept in such a manner as to be readable, together with the registration certificate issued to the owner, which at all times, will be subject to inspection by any representative of the police department.
- F. License Mutilation. It is unlawful for any person to willfully or maliciously remove, destroy, mutilate or alter the license sticker during the time that the same is in effect.
- G. License Loss. Loss of sticker by accident or other good reason, or its inadvertent destruction may, upon proper showing, be replaced by a new license sticker upon payment of twenty-five cents (\$.25) and re-examination of the bicycle or similar vehicle.

**10.40.040 Sale or transfer.**

Every person who sells or transfers ownership of a bicycle or similar vehicle shall report the sale or transfer to the police department, and return the license and registration certificate issued to such person, together with the name and address of the person to whom the bicycle has been sold or transferred.

**10.40.050 Equipment and maintenance.**

- A. Lights. It is unlawful for any person to operate a bicycle or similar vehicle upon the streets, highways or public places of the borough during the period from one hour after sunset to one hour before sunrise, unless the vehicle shall be equipped with a lamp on the front which shall emit a white light visible from a distance of at least five hundred feet (500') to the front, and with a lamp on the rear which shall emit a red light visible from a distance of at least five hundred feet (500') to the rear. In addition to the red lamp, a red reflector may be mounted on the rear, of a type approved by the Motor Vehicle Division which shall be visible from all distances from fifty feet (50') to three hundred feet (300') to the rear when directly in front of lawful upper beams of head lamps on a motor vehicle.
- B. Warning Signal. All bicycles or similar vehicles, when in use on any public highway, road or street in the borough shall carry a suitable alarm bell attached to the handle bar of the machine which, when rung, may be heard at a distance of one hundred feet (100'). No siren or whistle shall be used.
- C. Brakes. It is unlawful to operate a bicycle or similar vehicle upon the streets, highways and public places of the borough that is not equipped with adequate brakes which should be in proper working order during the time of operation of the bicycle or similar vehicle, after police inspection and approval.

**10.40.060 Riding on sidewalks prohibited.**

No bicycle or similar vehicle shall be ridden on any of the sidewalks of the borough. This chapter shall not prevent the use of toy bicycles or children's tricycles on a sidewalk by very young children, or children not over eight years of age.

(Prior code § 5-10.6)

**10.40.070 Skateboards, inline or other roller skates and bicycles on the sidewalks in the B-1, B-2, B-2A and B-2B districts prohibited.**

- A. No bicycle, skateboard or skates may be ridden, worn or used on any of the sidewalks in the B-1, B-2, B-2A and B-2B districts. This section shall not prevent the use of children's tricycles, big wheels or toy bicycles having a wheel or wheels with tires less than twelve (12) inches in diameter and shall not apply to children under the age of seven years.
- B. Violations.
  - 1. Any person over the age of eighteen (18) violating the provisions of this section shall, upon conviction, be punished by a fine not exceeding five hundred dollars (\$500.00).
  - 2. For a second offense, any person over the age of eighteen (18) violating the provisions of this section may, upon conviction, forfeit the bicycle, skateboard or skates used to violate this section.
  - 3. Any person who shall be guilty of a violation of this section shall, if under the age of eighteen (18) appear before the chief of police, with a parent or guardian, upon proper notice, showing the nature of the offense and show cause why the bicycle, skateboard or skates used in violation of this section should not be forfeited.

**10.40.080 Safety regulations for operation of bicycles.**

Every person operating a bicycle or similar vehicle shall at all times operate the same:

## Title 10 VEHICLES AND TRAFFIC

- A. With due regard for the safety of other persons and vehicles lawfully upon the streets, highways and public places, as well as for his or her own safety, and shall at all times and under all conditions yield the right-of-way to pedestrians on the streets, highways and public places and on the crosswalks;
- B. In compliance with all vehicle traffic laws which apply to bicycles or similar vehicles, and all vehicle traffic signs and signals erected for the regulation of traffic;
- C. Properly and shall not ride other than upon or astride a permanent and regular seat attached thereto. Nor shall he or she ride with his or her feet removed from the pedals, or with both hands removed from the handlebars, nor shall he or she practice any trick or fancy riding in a street. No bicycles shall be used to carry more persons at one time than the number for which it is designed and equipped;
- D. Without attaching the same or himself or herself to any vehicle upon a roadway. No operator of any vehicle shall knowingly allow any persons riding upon any bicycle to attach the same or himself or herself to the vehicle;
- E. In accordance with and shall obey all traffic regulations as established by N.J.R.S. 39:4-1 et seq. the amendments and supplements thereof, and all ordinances passed by the borough as to the regulations of traffic on stop streets, one-way streets and through streets.

Before turning or changing the direction upon any street, highway or public place, it shall be the duty of the rider to give a signal, by the extension of the hand to indicate the direction it is the intention to proceed.

- F. When riding a bicycle, motorized bicycle or scooter between dusk and dawn, every person shall wear light colored or reflective clothing.

### **10.40.090 Violations—Enforcement.**

- A. **Inspection of Bicycles.** Any police officer may inspect any bicycle at any time if he or she has reason to believe that it has not been validly registered, does not have its registration sticker properly attached, or has a mechanical defect which renders the bicycle unsafe to operate.
- B. **Impounding of Unsafe Bicycles.** If a police officer determines that a bicycle is so defective or unsafe as to constitute a danger to the safety of the person operating it or to others, he or she may impound the bicycle immediately. A bicycle that has been impounded shall not be released until the registered owner has given satisfactory proof that the defect that led to the impounding will be corrected prior to the bicycle again being operated in the borough.
- C. **Violations in General.** Any person shall be guilty of a violation of this chapter who:
  - 1. Fails to register a bicycle or similar vehicle owned by him or her and operated on the streets, highways or public places of the borough;
  - 2. Fails to report the transfer of ownership of a bicycle or similar vehicle as heretofore provided;
  - 3. Knowingly operates or permits the operation of a bicycle or similar vehicle owned by him or her, which is unregistered or which has a mechanical defect rendering the bicycle unsafe to operate or otherwise violates the terms of this chapter.

**10.40.100 Violation—Penalty.**

Any person who shall be guilty of a violation of this chapter shall, if under the age of eighteen (18), appear before the chief of police with his or her parent or guardian, upon proper notice showing the nature of his or her offense, and show cause why the registration of the offender's bicycle should not be suspended or revoked. If age eighteen (18) or over, any person who shall violate any of the provisions of this chapter shall, upon conviction thereof, be subject to a fine of forty-five dollars (\$45.00) for each violation.
