

Minutes Freehold Borough Board of Health
February 8, 2024

1. Opening

- The February 8, 2024 meeting of the Freehold Borough Board of Health was called to order by Chairman McGonigle at 8:00 PM.

2. Roll Call

 - Ms. Cannon reported that only one person has registered with the SPCA as a colony caretaker to date. The Report from the Monmouth County SPCA was reviewed with the number of TNR cases.

- 2023 Communicable Disease Annual Report
 - Ms. Nance from the Freehold Area Health Dept. reviewed the detailed report which broke down data on communicable disease cases by disease, by setting, by municipality and by month. She explained "Project First Line", the field work that is being done in facilities, community outreach, and presenting at a statewide seminar and School Nurse Forum.

- Ms. Nance, Epidemiologist at Freehold Area Health Department, gave an overview of her day to day responsibilities including; outbreak management, interviewing all reportable disease cases, providing samples of tracking forms (line list) and outreach and on-site trainings to prevent future issues.
