# Mr. Barricelli read Item No. 4 on the Agenda as follows:

Memorialize Resolution for Resolution No. 51-23 Redevelopment Plan Entitled "Downtown Freehold: Hometown Redevelopment Phase I Block 35 Redevelopment Plan" Pursuant to the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, et seq. Mr. Barricelli – when I was preparing for the meeting tonight, I was thinking about, although I had reservations, remembering Ron's charge to us, very simple; to determine if this is consistent with the Master Plan; so I will hold my questions and comments until the time of a proposed plan in the form of an application; anyone have a motion to approve the resolution;

Mr. Jackson – I have an observation also; there was a lot of discussion at the meeting about parking and Anthony had done some quick calculations; in the resolution item #3, "The Board recommends requiring a parking study as part of any Redevelopment Agreement"; I think it would be helpful if that also includes some language that indicates the department study would ensure compliance with the New Jersey Residential Site Improvement Standards which is what they said they would comply with in the plan; that would eliminate any question about what the parking studies intent is;

Mr. Cucchiaro – I will add that;

Mr. Barricelli – any other observations before we make a motion to approve the resolution;

Mr. Barricelli – can I get a motion please;

Mr. Ceppi – made a motion to approve the resolution with the added change by Mr. Jackson; Councilwoman Rogers seconded;

Mr. Barricelli - Councilwoman Rogers any update on anything;

Councilwoman Rogers – nothing at this time;

Mr. Barricelli – Mayor Kane anything;

Mayor Kane – all good;

Mr. Barricelli – Dominica, anything for the next meeting;

Ms. Napolitano – February 22, 2023 – full application;

Mr. Ceppi – Mr. Chairman in similar situations like this, we are here for 6 minutes, is there any consideration to have a call in option; I came in from Trenton, sure others may have come from other locations, second / third meeting this week and would be nice to see family; not necessarily video but telephonic approval this evening I think would have been appropriate; depending on the agenda or overall consideration;

Mr. Cucchiaro – you can do but have to make a verbatim recording; the verbatim recording is easier with video recording, it is the highest quality and clearest; you need to figure out with enough time to let

the public know and provide notice; the public to access; as long as we know a week or so before we can make it happen;

Mr. Jackson – would it be just as easy to move what we did tonight to the next meeting;

Mr. Cucchiaro – some has to do with the governing body, them having their second reading for the redevelopment plan, they need our input prior to that;

Mr. Ceppi – I respect the aspect to meeting time to do just that, just generally speaking;

Mr. Cucchiaro – we can make it happen but for purposes for getting out to the public with correct notice and verbatim recording – need to figure out in advance;

Mr. Barricelli – just observation, I found that zoom was unfair to the public; they didn't know how to participate; tonight, we didn't know if there would be a crowd, there should have been a crowd; that is another problem, especially with redevelopment;

Councilwoman Rogers – I think with meetings like this, approval of minutes and memorializing a resolution, I think that is the point Paul is making; no application to review, makes easier to have remote meeting; if an application we need to be in person;

Mr. Barricelli - yes

Mr. Jackson made the motion to approve the resolution, Mr. Ceppi seconded; All in favor – aye (all), nay (none);
