## FIREWOOD HARVESTING PROGRAM – 2023

### General Information

The Commission's Firewood Harvesting Program provides the community with an opportunity to obtain an inexpensive source of firewood while promoting healthy outdoor activities and supporting the maintenance of the Lake Topanemus Park.

### Here's how it works

Interested parties should complete the attached application and submit it to Sascha Duckenfield at Freehold Borough Hall. Applications will be reviewed and a Commission representative will be assigned to assist the applicant in securing access to the firewood and the park on one of the requested dates and times.

Firewood harvesting may only take place in the presence of the assigned Commission representative whose direction must be adhered to.

Applicants must provide their own equipment to cut and transport firewood including saws, axes, and chainsaws, etc.

Applicants may harvest as much firewood as they wish from designated areas at the direction of the Commission.

No standing trees are to be cut down or harmed in any way.



Vehicle access is at the direction of the assigned Commission representative. Speeds within the park shall not exceed 10 MPH.

The Lake Topanemus Commission, the Borough of Freehold, and the Township of Freehold assume NO responsibility or liability for any damage or injury whatsoever to equipment or residents due to the actions of the applicant.

Applicant warrants that they are experienced in the use of their equipment and understand that the Commission assumes NO liability for their actions.

Applicant alone is responsible for their party's safety and shall supply all necessary safety equipment.
