RESOLUTION MODIFYING METERED PARKING REGULATIONS AND RATES

WHEREAS, the Borough of Freehold, County of Monmouth (the "Borough") is a public body corporate and politic of the State of New Jersey; and

WHEREAS, the Borough instituted metered parking in certain of its lots and on certain of its street; and

WHEREAS, Borough Code 10.14.15 permits the Borough by resolution to temporarily amend the rates and suspend metered parking as necessary to respond to the needs of the time; and

WHEREAS, the Borough has discussed certain issues arising from the metered parking for the downtown business; and

WHEREAS, it is the desire of the Borough to temporarily amend and adjust the metered parking.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Freehold, Monmouth County, New Jersey, as follows:

- 1. That, pursuant to Borough Code 10.14.15, the Borough shall temporarily amend the rates and times of the metered parking.
- 2. That metered parking on East Main Street, West Main Street, Court Street, and South Street spaces shall begin at 11:00 a.m. and shall end at 11:00 p.m. Between the hours of 11:00 a.m. and 4:00 p.m., the fee shall be \$1.00 per hour in these spaces. Between the hours of 4:00 p.m. and 11:00 p.m., the fee shall be \$2.00 per hour in these spaces.
- 3. That metered parking is suspended in the Market Yard lot, the McGackin Lot, and the Borough Hall lot on Sundays through Tuesdays of each week.

- 4. That the metered parking times on Wednesday through Saturday are suspended between 11:00 a.m. and 4:00 p.m. and 11:00 p.m. and 3:00 a.m. (i.e., paid parking is limited to between 4:00 p.m. and 11:00 p.m.). The rate for these times in these lots are \$2:00 per hour.
- 5. That, unless specifically modified herein, all other rates and times remain in full force and effect.
- 6. That the provisions of this Resolution shall automatically expire on April 1, 2024 unless extended by the Borough Governing Body.
